

This authorization is exclusive to the state of Utah and its residents. Please place this certificate(s), in a conspicuous location in your establishment to enable customers to view that you have properly registered.

The business activity of title lending is regulated under the Act. The statute mandates the Department to conduct an examination of every title lender at least once a year. Once the examination is completed, a Report of Examination (ROE) is generated and mailed. The ROE will list potential violations if identified, and ask for a response. Your response helps us ensure compliance with the applicable laws and may mitigate potential fines which may be assessed.


